Tugure was established based on Notarial Deed of Raden Santoso, SH, No. 8 dated April 2, 1987.

2004

Tugure was appointed as the main pioneer for insurance cooperation among ASEAN member countries under ASEAN Reinsurance Exchange Scheme (ARES).

2012

Tugure strengthened its capital base by getting additional capital worth Rp19,99 on December 19, 2012.

2011

In June 17, 2011 Tugure obtained an additional paid-up capital from the conversion of dividend shares, amounting to Rp10,55 billion. In addition, Tugure also obtained an additional capital injection worth Rp17,12 billion on September 30, 2011.

2013

Tugure obtained subordinated loan worth Rp37 billion in order to increase company's equity. Moreover, the Shareholders provided additional capital of Rp9,4 billion on June 13, 2013.

2015

An additional capital of Rp65 billion was injected, via conversion of subordinated loan of Rp37 billion, plus a capital injection worth Rp28 billion.
